2717 - APOLOGIES FOR ABSENCE

2718 - DECLARATIONS OF INTEREST

2720 – CHAIRMAN'S REPORT, MINUTE UPDATE AND OTHER MATTERS ARISING

Cllr. Flack reported progress on the outstanding applications.

a. Minute 2701(c) - Portland Marina, Hamm Beach Road

The Clerk was further requested to contact Land Trust regarding the continued works at Portland Marina.

Concerns were raised as to the state of the land outside Mess Desk development as there could be dumping taking place.

2721 – PUBLIC PARTICIPATION

The Chairman was happy to allow members of the public to speak on specific concerns on new applications and agenda items as they occur.

2722 - NEIGHBOURHOOD PLAN

Mr Matthews updated the Committee. He mentioned that LPA regulation 14 was ready to move to the stage. The consultation date had changed to 18 June – 30 July.

Concerns had been raised on the second home policy and that of sustainable energy.

They were going to look to see if there were amendments issues outside the DDB.

The working party would look at considered amendments.

2724 - PLANNING CONTRAVENTION ISSUES

Further conversations were had regarding the application at 35 Easton Street. It was noted that work had already been undertaken before planning had been approved.

It was also mentioned that numerous apple trees had been removed without any known permission.

It was agreed to inform the Enforcements team of these matters.

It was also brought to the attention of the committee of a blocked path at St George's.

It was agreed this was private land and the owners had every right to secure it as there was deemed health and safety issues.

2725 – PLANNING APPLICATIONS NOTIFIED BY DORSET COUNTY COUNCIL

There were none.

2726 - HIGHWAY ISSUES

a. Parking issues at Station Road and Verne Common Road.

Cllr. Flack had met the senior office from Dorset & Wiltshire Fire & Rescue Service.

He mentioned that Station Road was a known issue and plans were in place to remedy this.

Verne Common Road had not been mentioned before so he would request that the Portland crew drove this area on a more frequent basis as part of their training.

He also mentioned that East Weare Road had been done.

b. Safer route to school along Park Estate

The committee were in principal supportive of this proposal. However, a number of potential were requested to be fed back to DCC. These included the possibility of overload of runoff on the new gulley and not being convinced the access from the garages would improve visibility. It was also suggested that DCC should speak to the CCG as they could
